Dear Whom It May Concern:

The billion dollar claims.

Further note on draft: Some ideas are not fully expanded, needs retooling to communicate seriousness of the acts, what the harm or viciousness entailed, etc.

This letter is a limited draft because of only 45 minutes per week on the computer/law library. I cannot really do a lot of work to summarize my experience without more access to a computer. Please talk to me in person. I also need medical care, which OSH/people are denying to me, and I'm being repeatedly injured with radiation and abuse. OSH has the duty to restore me to capacity but they don't apparently want me to regain any lost function. They are refusing to provide access to a specialist like a chiropractic neurologist, refuse to do any tests to prove injury like an MRI, ignore my own doctors opinion and other doctors who have been involved in the case, refuse to provide physical therapy to loosen my muscles, and refuse to offer therapy and rehab to repair brain/nerve function. Their stance is to never admit to or acknowledge abuse or my condition (which leads to deliberate indifference and refusal to admit to injury or need for medical care), and it basically results in them ignoring me, and chronic neglect/abuse. (when your muscles/body pulls tight, you have trouble communicating or thinking, and it leads to several life threatening problems including brain pressure and other issues. If your body can't move, you can't express yourself/feel emotion/cognition as well. This is why my case is hard to communicate. OSH/people know this and are holding me hostage with illness and remote control.)

This is a list of events and abuse incidents that occurred at Oregon State Hospital (OSH). I am going to try to compile specific events, going back from 2004 when my problems began with the state of Oregon and the hospital. I do not necessarily believe your claims that the jury wouldn't believe me when the record is analyzed, and that pattern and practice of abuse, misdocumentation (including falsified evidence and medical records, other libel, and serious damage) and unexplainable events has occurred. In addition, this helps to establish a history of prolonged and repeated violation of law and civil rights.

My problems with OSH and the state start in 2004. I was 19 years old and I had gone to my grandmother for assistance after years of isolation and neglect, and I wasn't getting help. My grandmother never responded to issues I had and left me alone for years, as did the school system, which denied me proper assistance and educational services since I was around 12 years old. She got upset and called police, who arrested me for menacing and harassment, instead of taking me to get help. I was emotionally fragile young person, I was alone and didn't know what to do to get help, I had no one at all, not even my own family. In jail my grandmother called and left several false or overly emotional messages, leading to mental health workers recommending I be sent to OSH for an evaluation. I told my attorney David Philips that I had anxiety issues, but I was fine, I didn't think I had a mental illness. I had no symptoms of a mental disorder from my recollection and no prior diagnosis (other than ADHD: Predominately Inattentive

Type as a young child), I was just really scared and it was the first time I'd been around people in awhile. I was a smart young person who spent years developing websites and community projects on the Internet, but I had little face-to-face contact with people. I had thousands of friends who used my services online. My attorney acted like most public defenders, like mental health issues were supposed to be some great escape from the legal system and could be used as a defense, despite me not having mental health issues. He seemed insistent on sending me to OSH for an evaluation, just to "get some treatment and see how things go. Everyone needs treatment." I had no idea how to stop the process or that it wasn't necessary, and he refused to listen. Without any psychologist examination to determine my ability to aid and assist (the only way they can send people to OSH under ORS 161.370 for mental health treatment is to perform one), I was sent to OSH. There I went without medication for 3-4 months, with a deferred diagnosis, until two staff members named Jeff Hudson and Kurt Hendricks assaulted me. During this period staff members were harassing me because I was on 1:1 watch, and I was only on 1:1 watch to help me around the unit. I felt uncomfortable around staff and patients, and staff were upset that there were 7 constants. They retaliated against me, got upset over "mandates" and the doctors' refusal to take people off constant. They sat around calling me names, one came into my room (Chris, who was fired months later for getting in a fistfight) who shoved me around in anger, while others staged protests against patients where they all got up and left their constants to watch TV, etc. When the normal doctor went on vacation, staff began acting up more, talking to doctors from other units, "he doesn't need to be on constant, take him off" etc. They tried to go behind the normal doctors back to get changes made, but the temporary doctor refused to cooperate. Staff started to get out of control about it. They started to be restrictive and harassive towards me, I believe there was a plot by staff to get me on medication due to anger and as a means of harassment and abuse. One time I was walking down the hall with Jeff Hudson and Kurt Hendricks, when suddenly they both turned to me and slammed me up against a wall without cause. They started attacking me. During the incident, RN Marylyn runs out and questions the two during the attack, "what on earth is going on here?" in an excited manner. Both of them suddenly turned the blame on me, "he had a pen". Even though I didn't do anything and cooperated, I was put into the side room, where RN Marylyn spoke to me. She said "you're lucky I was here, I knew you'd never do that". I believe they lied and said I tried to injure them with a pen. Another staff named "John Angus" witnessed their behavior and said something similar to Marylyn, they were watching out for me, at first. The problem was neither reported nor acted on the abuse, which seemed to be their method of operation, and many incidents started to occur where I was being bullied and ganged up on. At one point I received a shot of Haldol, Ativan, and Benedryl, a major cocktail of tranquilizers, which caused a major allergic reaction. This included my muscles spasming so bad I was bouncing up and down in a chair, severe restlessness, nightmares when I slept, and I was waking up with intense panicked fear and dreams, including intense sweating. I also started freaking out, I couldn't hold still. They didn't want to accept responsibility for it and failed to provide emergency treatment to reestablish stability. I complained to the new psychologist about it, but they did nothing. Later on, I was in restraints for no reason, they brought in an outside doctor named Dr. Suckow, who didn't do much of an interview or examination, and asked if I wanted to be put on Zyprexa. I had no idea what it was, he just told me it was a "new medication." I didn't know it was

an antipsychotic, I had no symptoms of psychosis, he didn't ask any questions about it. I was not psychotic and placed on Zyprexa as soon as the unit doctor returned, which was a medication used to disrupt the nervous system – causing dopamine blockage in the brain, resulting in the brain's inability to control itself, your muscles, and bodily functions – people end up with stiff muscles, damaged activation control, inattention problems, brain damage, and the drug causes toxicity and delirium. I was later diagnosed with depression, ADHD, and PTSD but I believe I was suffering toxicity only from the drug. During this period, and without my consent, my attorney sent a request to the judge to have a culpable evaluation done to see if I was responsible for my crimes (or eligible for GEI/the insanity defense). No one notified me of that request or told me what it entailed. So what ended up happening is, after my 3/6 month stay, my 370 “aid and assist” evaluation came up, which I passed. I went into the evaluation slightly impaired from medication, but I told them I didn't want to use the GEI defense and had other plans for dealing with my charges. They came back to me after I passed the 370 evaluation and said my attorney requested the second evaluation, to determine my sanity. They knew I didn't want to do it, so the evaluator called me back over for a special conversation a week before doing it. She basically coerced me into taking it, she asked me “didn't I want help?” The unit director on the unit told me I couldn't leave without doing the second evaluation, which was likely false, so I went through with it. My charges were originally menacing and harassment, two misdemeanors. They found I could have been mildly impaired due to abuse I experienced at home, and thus might not have been responsible for it. They said I had an episode of flash backs and intense emotion related to PTSD. Due to how this evaluation was conducted at OSH by court order, it was sent directly to the courts without my permission or review, exposing critical details and triggering the GEI process without my permission. As a consequence, my attorney David Philips refused to do anything else when I returned, and pursued the mentally health defense contrary to my wishes, apparently due to the mistakes. He may have felt responsible and didn't want to admit it or tell me about it, he said “what else are you going to do?” and refused to explore options. He talked with the DA behind my back and arranged a deal that wasn't in my interest. The DA apparently saw it as an opportunity to increase my charge as part of a plea deal, to unlawful use of a weapon, despite me not have done anything like that act. He didn't have to prove anything in court and it was merely his way to get me “more time” according to my attorney. This is not a fair deal or proper plea bargain. My attorney refused to help, and I was placed under the PSRB for 5 years, despite having no mental illness. No review to find out if I was actually guilty of unlawful use of a weapon was ever made, and no evaluation to determine if I was guilty except for insanity of unlawful use of a weapon was ever made. I was already on release to the community, and as part of the deal that's where I'd remain, without returning to OSH. I was seen as low risk and needing mostly community based support through the program. I eventually made it to a group home, where I received no help, and was mistreated with medication for months (for example, I was passing out around the house sick, being made sick from toxic medications I didn't need). I eventually tried to leave the group home I was in due to abuse and lack of support, and I was revoked and sent back to OSH. When I arrived at OSH, the hospital deemed that I had been revoked carelessly, didn't need to be there, and spoke with Lane County about accepting me back. At my first PSRB hearing on December 12<sup>th</sup>, 2005, weeks after getting there - My release was re-approved, pending

finding placement. But the process was sabotaged by the hospital when I encountered staff misconduct, including the Bonita Tucker scandal – I witnessed her do many wrong things and was abused by her, and fellow staff retaliated and lied about everything to hide what had happened. My release was still approved by OSH Feb 17<sup>th</sup>, 2006, “Conditional Release Pending PSRB Approval” at a hospital risk review board. I was supposed to be on my way out, when people involved got upset about me getting my privileges and decided that wasn’t going to happen. Before this happened, Roger Kalman of Lane County described me as “refreshingly honest” and wanted me back, he was even willing to let me go to a foster home to get me out sooner. Despite his support, I believe he jumped the ball and acted carelessly in having me returned to the hospital.

Here’s a summarized basic list of my claims:

Serious injury sustained at OSH from abuse, neglect, and improper and harmful medical procedures include: liver damage, damage to my vision, hearing, skin, muscles, heart, organs, brain, psychological abuse and serious injury to my memory and personality, cognitive ability, and serious denial of anything meaningful for more than 8 years. I was subjected to random torture, experimentation, gang stalking, staff misconduct and practices of manipulation, harassment, intimidation, verbal and physical abuse, sexual abuse, sexual assault, privacy violations including unauthorized use of brain computer interfaces and remote spy technology, mind invasive microwave and sound wave manipulation, simulated psychosis via remote brain computer interface and energy weapon, assault, battery, coercion, failures to act, failures to report, conspiracy to abuse and hide misconduct at OSH and within the legal system throughout Oregon. Likely crimes involved include multiple counts of Assault, Battery, Sexual Assault, Rape, Attempted Murder, Obstruction of Justice, Official Misconduct, Racketeering, non-lethal manslaughter, Reckless Endangerment, Disorderly Conduct, Coercion, False Imprisonment, Making False Reports, Treason, Terrorism, Sodomy, Acts of Torture, Kidnapping, Entrapment, Charges Related to Violation of the Constitution, Conspiracy charges related to both the intent to commit these crimes and to allow or enable others to commit them, and other related crimes. Events include abuse by numerous staff members, state, and federal agencies, including President George W. Bush and President Barak Obama (who both authorized such programs to exist and head each federal agency responsible), the Central Intelligence Agency (CIA), Federal Bureau of Investigation (FBI), National Security Agency (NSA), Military, and state agencies including the Oregon State Hospital (hospital wide, all staff including individual incidents: Jeff Hudson, Randy Davis, Bonita Tucker, Jeff Birkholtz, Kurt Hendricks, etc), Oregon State Hospital physicians (all doctors, including individual incidents: Dr. Fickle, Dr. Maynard Hammer, Dr. Newton, Dr. Skach, Dr. Dick, Dr. Farivar, Dr. Chi, Dr. Chen, Dr. Erwin, Dr. Brooks, Dr. Fritz, Dr. St. Just, Dr. Knott, Dr. Berman, Dr. Meyer, Dr. Martinez, Dr. Hannigan, Dr. Brewlski, Dr. Frank Sibel, Dr. Lundblad, Dr. Orsini, Dr. Jablonski, Dr. Robinson, Dr. Duran, Dr. Hansen, Dr. Paine, Dr. Greg Roberts, among others), police (state police: Sgt Withers, Sgt Terry, Detective Scott, Sgt Moly Carter, others – FBI: FBI Portland, FBI Eugene, FBI Salem, FBI Agent Roberts, FBI Agent Suttles – Springfield: Officers Grice, Bezates – Lane County Sheriffs: Sheriff Tom Turner, Sgt. White, Deputy Anderson, Major, J. Moore, Myers, D. Morgan, Hardy, Woolsey, Olsen, others – Eugene

Police Department – Other police departments that participated as I traveled throughout Oregon), Dave Logan of the Springfield Prosecutors Office, William Warnisher and Lane County District Attorney's Office, Psychiatric Security Review Board (Mary Claire Buckley, other board members), Attorney Harris Matarazzo, Office of Investigation and Training (Eva Kutas, Marrie Cervantes, James Myrick-Duckett (sp?), Andrew, Jenni, Ed, and others who helped cover up crime), DHS (Bob Nikkel), Governors Kulongoski and Kitzhaber and the citizens representatives who were watching the case at OSH, Lane County Mental Health and Roger Kalman and Jonathan Schwarts who helped hide abuse and took part in the project in the community, along with Lane County RiverStone Clinic (Karen Woodson and Dr. Fox, other staff), Medical Staff at Lane County Jail, Pretrial Services at Lane County Jail, and many private entities. Private entities involved include Disability Rights Oregon (Bob Joondeph, Beth Englander, Rebecca Lease, Kali Tara (now Kali Yost), Ester Harlow, DeAnn Major, Amy Sult, Glen LaFollette, Barbara, George Stall, others), Lane County Public Defenders Office (including Jessica Saydack), Margaret Megenis, Lane County Defense Consortium (Michael Buseman, Becky Davis, and 'Brad'), PeaceHealth including Riverbend and Sacred Heart hospital, and McKenzie Willamette, Laurel Hill Center (Shaun, James Brown, Darcy, Ben Yoder, Stacy, others), Shangri La Corp and their Myers Home (LaGeanna Boss, Eric Meyer, Jessica Chiever, Jessica Parker, Bradly Lilen, Vicki, Nicole, Patrice, etc, other house staff ;). In the community they needed staff in facilities to be involved to both help control me, and they wanted to be able to handle the situation without acting to take care of any of the problems. Certain people, attorneys were supposed to take care of "problems" for the county and state. I got what I got, which was nothing, while everything basically helped them hide what was going on. There's also the city of Springfield, Eugene, Salem, and Portland, and State of Oregon who facilitated the abuse and allowed the operation to occur without doing anything to protect me.

The conspiracy between the agencies was to have me basically murdered, and to deny involvement using secret technology that was capable of injuring through the wall. They planned to set me up to look psychotic, deny treatment, and hold me hostage until I died. They viciously mutilated and attacked me, played games and denied they were doing any of it. They involved both local and private entities throughout Oregon to help in the process.

-I am interested in justice, vindication, and protection from these mistakes, for me and everyone else.

2004:

-They failed to provide crucial psychological testing and counseling to avoid improper diagnosis, or to give me help with what was going on in the facility. I went months without in fear at the hospital, no doctors, psychological examinations, no counseling or support to help me with why I was there, or just giving me a person to talk to. I wasn't unstable, but I didn't realize I'd be there for months, or how to get out. They didn't talk to me to explain or get me on a plan of release. I already knew all my legal stuff, I started off from the beginning complaining that I didn't need to be there, and knew all the stuff in the legal packet. They should have offered counseling and guidance to steer clear of problems with stuff, and helped to develop a plan so that I wasn't assaulted or harassed

by staff, or left with unnecessary watches or orders. Staffs constant involvement in my case, the 1:1, led to harassment and over involvement in physical restriction and abuse. This led to them controlling and abusing me, and ultimately the assault and misdiagnosis. I needed emotional support and guidance, not mind altering drugs or continuous monitoring. I was emotionally fragile due to the trauma I'd experienced at home, the feeling of lost time due to isolation, and issues with missing out in school. They didn't even attempt to help with any of it (it may have been that this was the psychologists responsibility, but the unit psychologist had left and it took three months for a new one to arrive – but that doesn't mean I should have been neglected or without guidance and support). When psychologists finally did testing, doctors failed to correct mistakes and failed to offer proper assistance (extreme negligence and part of their practice of improper diagnosis and treatment).

-I was assaulted and bullied by OSH staff, including Jeff Hudson.

-Randy Davis was upset that he had to work more than 2 days per week and organized a group of staff to retaliate against me and other patients. Randy and other staff were verbally abusive, telling me "some people might try to tell you things will be alright, but I'm here to say they aren't going to improve. You should just give up and end your life". He said this the night before he left 48C to move to an apparently more suitable unit. Due to union duties, he was favored for time off and frequent exceptions to mandates, and tried to maintain a system of manipulating the system to work just two days per week. Randy told me he thought I should be medicated with Thorazine and pursued this as someone frustrated and used to dictating the circumstances of peoples medical care as a union thug and unskilled person (he possesses little formal education in mental health or health care, possessing only a CNA license that took little than weeks to obtain.)

-I was forced to take a drug that I didn't need and misdiagnosed to hide staff abuse. I developed toxicity, and it helped lead up to the development of a number of serious life destroying neurological and physiological problems including tardive dyskinesia, tardive dystonia, parkinsonism, memory and brain damage, nerve damage, inability to regulate or use bodily functions, extreme stiffness, eye pressure, damaged organs, damaged skin, damaged vision, damaged hearing, damaged sensation, and other problems. The hospital tried to hide this by diagnosing me as mentally ill.

2005:

-I was sentenced to the PSRB after my attorney made a number of bad decisions, increasing my original two misdemeanors to a single Felony C, which I didn't commit. I was already on release in the community, and that's where I stayed for a year.

-Lane County Mental Health and OSH failed to diagnose or correct the error, resulting in being over drugged and made chronically sick by drugs. I eventually attempted suicide because I felt I couldn't get free. I was passing out around the house and unable to stay awake, and the doctor just kept trying new drugs. I had none of these problems when I was younger and I hear it's typical for doctors to misdiagnose and mismedicate people, resulting in chronic sickness, especially with neuroleptic drugs – and the drugs cause a steady decline in people, resulting in serious brain and bodily injury. This is my experience.

-OSH continued the trend of misdiagnosis and medication errors, even though I tried to get off them. They were able to override my consent, because apparently the doctors were bypassing the medication override process, ignoring statute that requires administrative

hearings, etc. The doctors from the outside tended to work closely with OSH and as psychiatrists themselves, prescribed drugs as their primary treatment almost regardless, and rarely disagreed with or went against OSH. They also tended to use only destructive treatment options, and no alternative treatments.

-Issues with Bonita occurred. She forced me into an inappropriate relationship and inappropriately touched me, including pretending she was my girlfriend and touching me in a sexually inappropriate manner. She wanted to meet up when I got out, and gave me her cellphone and email address. Her intent was to have a sexual/personal relationship. I rejected her advances, and I was upset about it. She and staff who were involved tried to sabotage me to protect her and the situation, and this meant making up a bunch of lies. I witnessed her bring in contraband and tried to get help, but she lied about it and the institution/staff are very coordinated about covering up abuse and scandal. She and staff claimed I stalked her, was a sexual predator, manipulator, psychotic, a pedophile, and a codependent rapist, as a way to compensate and discredit me. That is abuse, slander and defamation of character. They began to falsify evidence and my medical record, which was shared with community providers and helped destroy my life. I couldn't overcome their lies, or control.

2005/2006:

-February 17, 2006: Granted final approval from OSH to leave. I was also given full off-grounds/on-grounds privileges on 48B, as I was expecting to make trips and get released directly from maximum security. This would tend to collaborate that I'd done nothing wrong and they were trying to hide the Bonita Tucker situation, at first. I ended up transferring to unit 50G later that day so that I could have more freedom. Staff there were upset I had my privileges, Dr. Chen tells me, "I hear you're a manipulator" and I hear comments about how I'm a stalker/sexual predator. Dr. Eugene Jablonski tells me not to talk about it when I try to tell him about Bonita and abuse – he wanted me to forget it happened. Staff called me names like "shit" and called in sick on days of passes, and they refused to take me on passes to Lane County, screwing up my release.

-Staff sabotaged my release and I was stuck at OSH. I was verbally and psychologically abused by staff, who also refused to work with me, provide services, counseling, or therapy, including Dr. Eugene Jablonski and Dr. Lisa Orsini, Dr. Chen and Dr. Berman. I was medicated and they claimed my reports of abuse were delusions or that of mental illness when these events did in fact occur.

-July 2006: OIT investigates Bonita Tucker. (See [bonilied.pdf](#)) Nothing is done about abuse. State Police attack me in interview, and I'm sent back to 48B for no reason.

-In December 2006, I was assaulted by Martin Turner over a pizza I had ordered, he got upset when I questioned him about taking it from me, at which point he ran and jumped on me, slamming me into the floor and hitting me in the face. Many people witnessed. He had a history of getting into fights with patients, including an incident months earlier where he was in a fistfight with a patient in the staff office. He reported hitting the patient several times in the face. Staff who witnessed the incident with me cleaned up my blood and broken glasses, and thought Martin had taken it too far. Michael Stucky said "I think he just takes things too personally" and "I think there's going to be another investigation" – Another witness was "Matt". I reported this incident in a grievance, to OIT/the state police. Days before the state police arrived, a nurse practitioner examined my nose for the yearly physical, documenting blunt trauma in my nose. The police came out and

examined me, and told me they needed a doctor to take a look. They apparently talked to my friend about a report from staff that I'd sexually harassed him, which he denied – but it was an effort by OSH to build a case against me that I'd sexually harassed Bonita and other staff. I saw doctor Brooks, who as part of a method to hide the abuse, documented it as a sinus infection and even prescribed a sinus infection pill. She reported to police I had not been assaulted, but there were many witnesses. "Marcy" cleaned up my blood, my glasses were broke, and staff and patients, including friends witnessed it. Martin assaulted two other patients months later.

-Dr. Skach coerced me to take Seroquel after Martin Turner assaulted me, threatening to take away privileges and further make my stay difficult. Dr. Fickle reported to my advocate that I was the boy who cried "wolf" over the incidents. I believe I was being targeted by the hospital and doctors for making complaints, and that they're used to getting away with misconduct and treat the patient as if it never happened – they're very organized about how they deal with it, including staying silent and pretending they don't know anything about it, and union reps aid in making up alternative explanations of how abuse occurred or stories to discredit the patient - and they were trying to hide the situations that occurred by claiming I was psychotic. (The state not only accepts staffs lies, they seem to expect them to be ready with a justifiable excuse. Staff never get in trouble, and abuse is never validated, nearly protocol. It's all a sneaky process; even when serious abuse or injury occurs, it's never substantiated.) On Seroquel, I began to get extremely stiff muscles, developing dystonia, including all symptoms of neuroleptic malignant syndrome – sweating more, high blood pressure (it was as high as 190/90, up from a perfect 100/60), I lost hair, couldn't move my head, etc. I informed Dr. Skach who told me "don't move your head then". She was letting me get slaughtered by the medication, due to deliberate indifference and my legal troubles with the hospital. Meanwhile Bonita Tucker was running around OSH smuggling in large quantities of marijuana, bolt cutters, and engaged in a romantic relationship with David Anderson. John Eastman was another patient she smuggled in drugs for, who claims he was set up for what she had him do, including distributing the drugs throughout OSH. He was charged, while she wasn't, and they hid her involvement. Donald Stewart was another witness.

2007:

-After Bonita helped with the escape of Gino Puglisi and David Anderson, she resigned, and uncoincidentally I was moved to 41A, transition coed unit, despite OSHs claims I was a sexual predator. I complained about Dr. Skach and my muscles moving, I was losing memory, etc. Previously I scored very high in the GED, nearly getting honors and a 800 on the science test (perfect). My scores were in the 88% percentile. Dr. Fritz seemed to be covering for OSH, despite obvious EPS and dystonia – he tried to deny I had any problems, and wanted to keep me on the medication. So I refused it, which is when OSH brought in Dr. Suckow for an outside consultation. OSH was trying to put me on a deadly drug called clozaril, their way to reinforce and frame me to look psychotic (a note on Clozaril: this drug is notorious for causing death and is supposed to be considered a last resort only for true schizophrenics who don't respond to other drugs. I didn't have this diagnosis.). Dr. Suckow indicated that I was being abused by OSH and had no such symptoms, had ADHD, and recommended treatment. This would pretty much invalidate everything OSH had done before, including two previous medical overrides where I was

found incompetent despite being very smart and informed about medications and treatment. I was seen as very savvy by outside doctors. OSH merely had me on medications to have me on medications, including for staff convenience and due to early coordinated effort to harass and bully me, and to persuade the doctor to medicate me for the staffs own purposes. They didn't want to admit to mistakes, and I swear they intended only to hurt me with the medication. It was a plan to injure and make me forget who I was, make me incompetent. It's like they were planning to slip me the most powerful toxic substance in their arsenal on purpose. (Medications like Clozaril are very powerful and target both good memory and function as well as "delusions" and other behaviors. In fact, they don't target mental health symptoms at all, and are designed generally to suppress and damage all nerve and brain function, and they seriously injure every person who takes the drugs. People who take Clozaril are never the same after taking the drug, and like other drugs, people continuously decline and become incapacitated. The doctors are very familiar with how these drugs work, and how they're generally unsafe and can be used to injure. This was the hospitals plans all along.)

-Dr. Fritz refused to provide ADHD treatment and I was further retaliated against. Dr. Fritz knew what he was doing.

-Staff began to talk about what happened on 50G and outside staff members telling them stories about me and Bonita, and treated me oddly sexually. This included staff members Marcy from security (a friend of Bonita), and Chris Pahl, a mental health specialist. Likely 48B staff.

-I was sent back to 48B for no reason after this, where I ran into situations with staff members. Michele McGraw-Hunter (41A unit director) agreed there was no reason for it, and offered to take me back. She told my advocate she'd heard I merely had anxiety about a move, but Dr. Fritz told my family that it was because I wouldn't take my medication. Others reported that they had no idea why I was moved and that I'd done nothing wrong, they told my grandmother and Glen LaFollette this.

-This is when I went to 50F, where Michele met with me. I was working on post conviction relief and a lawsuit against OSH about medication abuse, to change the informed consent override process. OSH had not been in compliance with the rules and we sought to fix that. Staff members on 50F were paranoid about this and eavesdropped on calls, they were also worried that Dr. Robinson had prescribed Haldol shots without my consent and that Glen was upset about it. They were telling me things, "well he's a good man" and stuff, calling me names, "he's dirty water". I talked to Glen over the phone when I heard from Donald Stewart what Bonita Tucker had done, I was upset because of everything I had been through, how my release was sabotaged. Glen told me to be quiet on the phone, that staff were very aware of the situation and would come after me if they heard about it, I asked about trying to file a lawsuit or complaint but he suggested seemingly with personal interest that I should not pursue that. I think he was worried about personal involvement behind the scenes with staff and failures to either document or act on the abuse, he also never really helped on my issue with the hospital and my release. Everyone knew what was going on and just not helping me.

-On 50F, I spoke with Marcy a staff who I thought was a friend to me and my family. She knew Bonita, and I told her about Martin and the assault. She goes, "I'm so sorry, I didn't know that was you, I cleaned up your blood" and I asked her about Bonita. She goes "none of that was really true about Bonita, was it?" "you loved her right?" "I remember

the way you used to look at her, you were in love, even back in 2004” – I said “No, that’s not true, and she did all the things I said”. She stands up “oh my god” and storms out of the room. Later I catch her in the hallway, and ask her what happened. She yells out “NO I WILL NOT HAVE SEX WITH YOU <my name>” then storms passed, I follow and say “but I didn’t say anything” She responds. “I know...” and leaves the unit. Many staff witnessed, including one named Scott, who told me while smirking, “should have stuck to your contact person.” It seemed deliberate. Soon after I was transferred back to 48B. -On 48B, Bonita Tucker was seen driving by OSH waving at David Anderson through the window. She also called OSH and talked to both David and other patients who she’d messed around with, including Clifford Beers. She should have been in jail for several serious felony counts, instead OSH/the state had decided not to prosecute and was trying to hide the situation at OSH. On one occasion, I answered the phone when Bonita Tucker called. I acknowledge it was her, “one moment Boni”. She wanted David, so I went to get him. When he got there, I heard him say on the phone “it was <my name>, why?” moments later he erupts in anger, begins to verbally threaten and physically gesture to assault me. “Don’t you ever say her name again.” “I will kill you, and that’s not a threat, it’s a promise”. He began to shove me across the room. She had apparently told him to attack me, and she then began collaborating with staff members including many who kept in contact. She erected a story with staff to protect herself, according to them I had got on the phone and began to threaten her, call her names. She was innocent old Boni and the state was dead set on protecting her and the situation. Staff denied anything was occurring on the unit while staff harass and made fun of me, allowed David to come by my room and harass me. He would bang my door and threaten me. He’d stir up situations among patients, start threatening me, and staff would come after me and throw me in the side room afterwards. It was staff sponsored abuse. I was working with Glen LaFollette on the situation who was concerned and had me open a new case with OAC/DRO. He had communication with the unit about these assaults and problems, though nothing was getting done about it.

-I met with the social worker named Frank Rauschman who had previously worked to get me out of OSH. After Bonita Tucker happened, he shunned me and refused to help. Now he seemed sympathetic and told me, “you should have got out, I’m sorry – I cannot help, we’re not allowed to talk about the situation”. Frank Sibel also reiterated similar sympathies, he told me. Don’t you know who tried to say you were a sexual predator? It was Stacy Carabello, and I’m upset about Boni – I’ve went to administration but they are doing it the way they want to”. I cried after I left the room, and he seemed to noticed how effected I was by the situation. He went into a protective mode, like it was going to get blown out of proportion “maybe there is something we can help you with” – like a threat. -There was an odd meeting with the treatment team after this which involved the staff denying anything was happening, and Frank Sibel jumping in his chair when I mentioned having a meeting with him. Staff claim I’m interfering with David’s treatment and I seemed to be the one causing the problems. I didn’t do anything though, I never said anything to anyone. I was being set up.

-Weeks of abuse went by, David was tormenting me in a lunch line one day in September 2007, and Jeff Birkholtz came out into the hall to laugh at David’s abuse. I run down to the doorway, Jeff’s serving lunch. I asked “what’s so funny, Jeff?” He slams his serving tool down loudly, and runs out and bumps chest with me. He threatens, “lets go” “right

now” – he stands in my face for a few moments as I tremor in fear, and staff look around at him. He was upset I called him out I think. He backs down and tells me to go to my room, which I do. Staff Jennifer tells me to write it all down – and I do.

-October 2007: Superintendent Dr. Marvin Fickle and OSH Security Director Don Able resign, apparently over the scandal.

-October 2007: Later in the day or week I am assaulted by Adam Collier, who was apparently in the same room as David. He comes up to me while I’m on the phone and beats me senselessly, over 15+ punches to arms and chest, and moments later I go down to the air court and wait to get transferred off the unit. As I’m about to leave, two staff come down, Rex and Hose to transport. Jeff Birkholtz runs down, “just say the word, and you’ll stay.” I don’t respond, and he tags Rex to leave. He’s going to transport me to 50C. All of this was recorded. We leave the unit and he immediately begins to verbally threaten and abuse me. “You’re nothing but a borderline bitch” I respond it’s abuse and I’ll report it. Jeff Birkholtz responds “so what, Hose isn’t going to say nothing. You’re all mine bitch”. In the tunnels he tells me, “I’d do the same thing as David if you said that to my girlfriend” and I respond “I didn’t say anything..” He goes quiet and blank for a few moments. He starts to act like an airplane and acting crazy, “I should beat the shit out of you and plead GEI, come in here and escape the legal system and you’ll be stuck with me”, making airplane noises, looney sounds. Towards the 50 building he says, “I am gunna make sure you get taken care of, I know everyone in the hospital, everyone is going to know about you, and you’ll be back in my control in no time”.

-October 2007: I get to the new unit and staff refuse to take picture, I have solid purple/black bruises bigger than a bowling ball across chest and arm, staff ramsack my legal paperwork, start making noise around me, “he knows what he’s doing,” “he’s a masturbator? I don’t like him already”. (staff claim to have recordings made with a machine from outside of the building of me in the shower, staff/DRO/OIT spying and have odd conversations appearing to know what my thoughts and private actions had been. This is when my relationships began to break up because I wouldn’t go with the flow or accept the cover up, and they were refusing to help.) The unit director is the only one not directly harassing me. He tells me he specially requested that I came to 50C cause he was the unit director on 50G, and he remembers how I wasn’t psychotic, didn’t do anything wrong, and he didn’t know why I was still here. He says he supported going back to what happened at my first PSRB hearing, we’ll say you shouldn’t be here and try to get things back on track. Other staff were not in agreement and tried to sabotage this. This was around the time the spying with psychotronics and remote technology began, they were spying on everything I was doing, harassing me, refusing to help, OIT documented that none of this could have happened despite video footage and recordings of it, Ed Stallard from OIT jumped when he saw I had a copy of the Bonita Tucker report, they were trying to hide the abuse. James Myrick-Duckett comes out from OIT and acts like he knew everything that went on, he brings up ADHD like he knew about what happened over the summer. “do you have records from when you were younger?” I asked why he asks, he says “I’m just trying to help you..” James says none of it happened despite dates and times and witnesses on 48B, along with security footage. Staff were using the technology to be cruel and to control me, they tried to interfere with everything (they even sabotaged my post conviction relief effort). It later comes out that OIT was involved in the spying, called a ‘live wire’ and the hospital lacked liability insurance. I

almost caught them because the discussions were on the video/recording system. I was assaulted by Jeff Hudson, other staff, they whistled and set me up to look psychotic. I was being bullied around the hospital, by very organized thugs who had the agenda to build a new hospital to their liking without interference.

-October/November 2007: Documented as having severe internal dryness, nose dryness, eye dryness, and maybe muscular problems from Seroquel/Effexor/Limectal withdrawal. I am left tense and partially crippled from the damage the drugs caused. Staff abuse and the assault from Adam and others trigger traumatic physical and neurological problems, mental anxiety and issues. I was physically and mentally hypersensitive, classic damage from the drugs.

-November 2007: Met with Harris Matarazzo, the PSRB attorney. (he was later involved with the OSH situation, the secret settlement, hung up on me on the phone when I told him I had proof about OSH making up stories, contradictory information and lies about everything) I told him about Bonita Tucker, he already knew. He goes, "well, she didn't have sex with you, did she?" I told him I had a report about her having a history of boundary problems, and I saw him chuckling. He said he was on the hospitals side and refused to examine my documents about it.

-December 2007: days before my 2 year PSRB hearing (I was still approved for release) where the burden is on the state to prove I still need to be here, I was transferred from 50C back to maximum security 48C for no reason (preparation for the hearing?). This was a special transfer by Dr. Marvin Fickle, the previous superintendent. Some abuse and situations were occurring on the unit that he was involved in, and I believe it was an attempt to sabotage the possibility of my release. 48C was a special unit for 370's, a completely different type of program (it was odd I was there, because I was a PSRB). The night I get there, staff are talking about me, "he's antisocial" "they took his computer" "oh, what a coincidence, it's the stalker!" - The spying and abuse continued there, I had gotten broken wrist and slammed around, women flashed and moved their breasts around in front of me improperly, acted like they were coming onto me in a cruel manner, I was being touched by different staff funnily on purpose (they made an effort to touch me). Something about someone claiming I was a codependent, stuff about Bonita and the touching, codependents are adults who enjoy fondling and child like affection, and have sick sexual fetishes, different needs to be touched. I was confused by it and upset. I was called names like rapo and faggot, and many cruel things happened during this period. They wanted to frame it as a mental or psychological / developmental problem, and basically make it all out to be my problem. Part of the claim was also that I was a withdrawn schizophrenic and this was part of my child like phase. They had a lot of sick perverted and nasty things to say about me.

-December 9<sup>th</sup>, 2007: State accidentally hands over copy of public record they were trying to suppress about the escapes and incidents with Boni, staff on unit going crazy about it. Statesman Journal publishes the article on this day about hospital security issues. (See statesmanjournal\_12-09-2007.doc) I am being abused and controlled by staff at this point, harassed, spied on, etc. I was the key witness/victim.

-December 12<sup>th</sup>, 2007: I go to my PSRB hearing, where I'm slammed around about how I was on maximum security. "get yourself together" they say, like I'm the one with the problem. My attorney does nothing to defend me, the doctor who testified didn't even know my case, and they claim I was possibly "traumatized" by what happened at OSH.

The attorney general bashes me and acts pretty aggressive this time around. My attorney does make a statement about OSH not following the PSRB's order to grant my release. I believe Harris, the hospital, PSRB, and state planned to make it sound like I'd been the one causing the problems, and thus they denied my release without either hearing my claims or investigating the matter (which I'm aware that they already knew about anyway)

2008:

-February 2008: Jeff Birkholtz was never disciplined and is promoted to Unit Director of 48B. Randy Davis runs around 48C talking about it, "he's been promoted to manager. He's got really good incite into these people, he'll help us get what we want". He'd been waiting a long time for Christie Galagoes (sp?) to leave 48B. In February, Jeff Birkholtz tires to make a deal with 48C unit director Ted Highberger to have my transferred down to 48B, "back in his control". They make an excuse that patient Adam Collier has assaulted someone else, and they need to transfer him up to 48C. Of course, it would make me uncomfortable the Unit Director of 48C tells me, and they need to protect me from Adam by transferring me down to 48B. I complain that it's the staff I'm really afraid of, and he refuses to accept that. "no, the staff didn't do anything". "are there any other patients you're afraid of?" I was crying about it, I had done nothing wrong. Ted agrees to compromise, "I will report you will see it as punishment, would you go to another unit? How about 50E, or 50H?" Before any of this happened, they sent my teacher, Helen Macy to spy on me and see what I would say about it. She didn't tell me about the problem or need to transfer, she just asked me questions about Dr. Chen and 50H. Ted Highberger transferred me to another 370 unit, 50H, "for my protection", where problems continued. I don't think they planned for it to last, and they eventually transferred me back to 48B, in Jeff's control. I recall the 50H unit director Dave Fischer on the phone with the program director Sue Zakes, they were discussing me and how I wasn't dropping my claims about the staff, how I just told staff about my story, and complained about misconduct and harassment. I heard him say "I think he just needs someone to talk to" in a supportive manner. I believe she was trying to have me transferred back to 48B over the complaints I had made (I told my case monitor about Bonita Tucker, incidents at OSH, abuse. I also complained to an RN who touched my hand seemingly on purpose about sexual harassment and bullying, and asked her if her touching my hand on purpose was related.)

Side note: I am not even bothering to try and explain it at this point, need to rest, will finish this in person. There's many daily details that will just have to wait. I remember everything well, there's too many daily events actually, it's just it goes on with many incidents and issues. I am physically and mentally exhausted.

-April/May 2008: many incidents, see detailed log sent to Superintendent Roy Orr, Oregon State Police, FBI, Governor Kulonski's office, Bob Nikkel, including a long email with dates/times/camera incidents including suffocations, abuse, staff commenting on abuse. Boni kept on engaging in disruptive behavior, thought she was home free due to state protection. (The states interest was in protecting itself, protecting the US DoJ investigation, and hiding details from the media.) She tried to send in morphine and amphetamine through the mail, married David, and the previous article about hospital security prompt charges against Bonita. She goes into court acting like the victim, and the hospital staff and watching me and the issue closely. Most of this was kept from me. In

May 2008, staff steal and hide legal notes that I wrote to attorney David Daniel, they allow David Anderson and Chris Walker to assault me, and then protect them. (staff say the police observed the assault through the wall, wouldn't be pressing charges, and staff would later act like I was the aggressor). They hide the incident and hospital refuses to investigate. Jeff Hudson has notes, several staff involved, they reading about it and commenting on the unit. "Why did they hide his case? they think the hospital lacked liability insurance. The notes are too incriminating, and the judge already made his decision" various comments. Staff say I'm being watched with technology from something "outside the building". "Get him into restraints at all cost" – they began deliberately bullying me around, and I get put into restraints for no reason. Staff looked for opportunities to claim I was doing something wrong, or to engage in physical contact with me. I did nothing wrong, staff going by door, kicking it "we're not afraid of you" and "no one cares about your rights, no ones' going to help you," whistling and shouting while going out to their cars. They were going crazy, I had caught them on camera talking about it all, psychotronics their use of it at the hospital. This was around the time I was medicated for 20 days (considered serious assault/battery) without following the medication override procedure. Dr. Suckow was called in both times, and each time he said it wasn't allowed. Staff did it anyway, and DRO allowed it. Dr. Newton was my doctor at the time, and he tells me, "Looks like you're having trouble finding an attorney, I don't think I have to help you." Everyone was together.

-Towards the end of May 2008, staff think I contacted the FBI and begin scrambling on the unit, running around and ship David Anderson to a new unit. They had brought him over just to harass and engage in bullying with staff. Days later they observe the situation or hear from the FBI, "they're not going to do anything" says staff. They resume assaultive behavior.

-Dave Hampton an RN comments, "we had to violate his rights just to say he does/doesn't have ADHD?" – they were upset about what they had gotten themselves into with this technology, that they were going to get caught, and it's possible other parts of their program were going to get exposed. This was a comment related to their use of experimental brain reading and manipulation technology at OSH. They had used the technology to peer into my brain and bodies function, and to monitor me for staffs own purposes (for harassment/control/otherwise), and they had used it to either invalidate or validate my diagnosis of ADHD; everyone was involved, DRO, and doctors from both inside and outside OSH, the governors office, and even legislature. It's possible it was also used for security purposes while the hospital was investigated, or the hospital was getting secret help in straightening out it's security problems, although it was aimed at controlling the patients versus exposing abuse or staff corruption. Possible secret reasons this technology was installed at OSH is it's being secretly used to spy on inmates, the government also is secretly installing and using these devices for inmate monitoring and for staff to use for security reasons. It's also possible that OSH was being used as a test bed for brain mapping and mental illness research using this technology, or some combination of all this. OSH may have been a prime site for illegal research for years, which it is definitely guilty of, but to what extent is unknown. I was put on the radar for trying to expose all this.

-DeAnn Major of Disability Rights Oregon approaches me secretly in the hallway (I never met her before). She knew exactly who I was and what I looked like, she holds out

her badge without speaking to me directly, as if to send a secret message. She stares into the kitchen instead of at me (while her badge was being held in my direction), and says in front of me, "I'm wondering why someone who should be out is still here?". It's as if she wasn't allowed to talk to me directly and wanted to send a secret message that she knew what I was going through and wanted me to call her/DRO for help. When I call, they refuse to help at first, then after complaints, she comes out. Staff are talking about how Bob Joondeph has ordered her to come out because of my complaints about my "disability," they are saying on the unit "she doesn't want to but if she finds something she'll have to do something about the abuse". Our first meeting was very special, she tells me she wants to help build my case for the USDOJ. I tell her about abuse. After the meeting ends, she waves me back into the kitchen, and says excitedly, "I'm going to help you build your legal case". Before she came out, I had been unsuccessful at finding an attorney, and my belief is she was going to help collect the facts to build my case again OSH (People may have told her about my difficulty before ever meeting with me. Hospital staff were having secretive but non-supportive meetings about me, it's possible she was involved.). Later, I hear staff talking, things happen. I overhear the supervising RN Roger speaking, telling staff she doesn't want to set a precedent, and that's why she's not doing anything. She switched over to helping staff hide abuse, she refuses to check security footage for fear of catching staff during acts of abuse. Some stuff happens where she tells me not to write any more grievances and when I ask about filing a tort claim, she exclaims, "no!.. erm, I mean you could if you wanted...". I complain to her about how she could have came out a month earlier and caught the staff doing all these things, spying and abuse, I was very upset. She tells me, "...the technology exists". At the time I thought it they were using the video/microphones to do the illegal spying, but this appeared to be a reference to her secret knowledge of the technology that was being used at the hospital. Staff were apparently watching us both as the conversation was occurring, and I believe that night the hospital set up a secret observation using the technology, they are talking about Dr. Maynard Hammer watching me to see what happens, he reports that night "he doesn't have any respect" before the night is over. Staff on the unit asking about it once the new shift begins at 10PM, people saying "it's already over, they won't help him". Jeff Hudson runs by door screaming, "he's probably going to say she told him not to write any grievances or torts, lol!" Staff come by door kicking it, "we're not afraid of you, lol". I call DeAnn Major and tell her I wouldn't do that, and about what the staff had done. The next day, staff are saying on the unit, "there's a bunch of lawyers down stairs, they're tearing into Jeff Birkholtz." Someone comments, "they used it on her?" "he's trying to say he masturbates, and that's why he's no good." They were making up excuses for being cruel and using the technology to abuse and control me. DeAnn Major apparently commented that "all boys masturbate" – she was trying to defend me. Time goes on though, more secret meetings and observations occur, they're sending secret messages to me. I'm having difficulty and they're thinking about arranging a settlement. At some point it falls apart, staff say they think I'm "stuck", there's no reason to do anything, and won't expose what's going on. I manage to hire an attorney and she immediately shows up the next day offering special treatment/services, she seemed anxious and stressed like she was being forced, like she had been caught not doing her job. Staff comments later that she felt she was being blackmailed and that's the only reason she was trying to help. During most of this period, she was really protecting staff,

and her offices involvement in allowing the illegal spying/experimentation. Staff members at one point comment that the security footage was being saved in case "other crimes" were committed (they were worried they were going to get caught). I made many requests for it to be saved for my protection, as part of grievances and the email I sent out previously (which should have counted as a tort claim notice and criminal report). It's possible that the security footage being saved is why I was targeted, they wanted to protect the abuse and technology. The footage, along with audio, was saved in case other crimes was committed, like they couldn't see all what was going on when they looked. They didn't tie it to the technology. The other reason for saving it was liability issues and compliance with protocol. If it doesn't exist, they intentionally destroyed it.

-I was savagely beat by Jeff Hudson at some point, suffocated on camera, and other incidents occurred that they were trying to hide. Pictures of messed up face available, but OIT/hospital try to deny any of it happened, despite camera footage. Staff get together and claim I did it all to myself. There were many witnesses to the Jeff Hudson attack.

August 2008:

-Psychotronic abuse and control begins. Microwaves/ultrasound through the wall into my body, they try to blow my body up. They tell me, "like you spy for the Statesman Journal (I was trying to tell them about the events/Bonita), DeAnn Major spys for the CIA". "you're being set up to look psychotic". I begin to convulse, go into shock. I'm up all night, they're talking to me, playing a game about how DeAnn Major wants to deport me (to where I belonged). They refer to it needing to be an emergency for a 'private transfer', the so called deportation - my belief is it's an option DRO has as a protection agency, or there's something within Oregon statute through OIT or administrative rule. They originally tell me they want me to call DRO, that DeAnn Major is extremely sorry, she wants me to have my own group home, \$16.4 million dollars, it was all done to help me "finish what I started," talking with romantic hues in the voice, she thought I was "sweet," she intends it all to be romantic. "you'd go good together". Staff play games like it would "break my heart" if she didn't help me, and it's a game to set us up to be together. It was also a game of torture to push me to her, so she could pretend investigate. "No ones ever made it this far" "if you don't hold still we'll pop your ear." "we're getting tired of staring at your anus" "why do your balls swell?" "she'll come have sex with you if your eyes stop rolling (I was convulsing)." "we can still see your eyes moving with your eye lids closed" They played a game like I had to hold still for 2 or more hours, it was a new security precaution in place, I had to lay still for her to come help. They promise DRO wants to help, someone will overturn my conviction. I wasn't criminal; they think my family and the state neglected me. I was the boy left to his own devices. They played a lot of games. I hear staff voices, including Dave Hampton and another speaking. They were using the technology to talk to me; they called the stimulation "parakenesis," and conversations "abusive rhetoric." I begin to convulse and go into shock, they say I am being set up to look psychotic and begin automated torture and rape with technology. Nothing ever happens and staff go silent on the unit, claim I'm in a coma, I'm never going to come out of it. They begin to speak about how it's an ancient Chinese secret, a special treatment, and begin to simulate massage on my buzzing and convulsing muscles (with resonance, heat, and sound waves). They tell me DeAnn Major will take me to get a Swedish massage when I get out, "she'll be your best friend". She eventually quits DRO and I am given a dream about Bone Thugs 'n Harmony. She was

going to be my mentor, as we'd talked about, and Bone Thugs 'n Harmony had a deal with Crazy Bone and his mentor who was also a member of Bone Thugs who past away. They had a whole thing tied to her, like she had died. They called it "bone strong" and talked to me in a really emotionally soothing voice, it was our special connection. It sounded really funny. I feel drills inside my body, my muscles and organs are whipping around, and overtime everything slows but everything hardens and stiffens to the point that I can no longer move. Can't flex ears, muscles, nothing. Everything hurts. It's a 24/7 endevure, they never stop, every time I lay down they massage my muscles, eyes, throat, heart... got my insides are so hard and messed up now. I was pretty much abandoned by her..

-Time goes on.. read story.txt and cia.txt available at [www.oregonstatehospital.net](http://www.oregonstatehospital.net) for additional details.

-No one wants to incriminate themselves and I get released to the community mutilated and crippled, and a "prison" is set up. Everyone in the community participates, including all my community providers, and local governmental and hospital infrastructures. They are working closely with the hospital and the people using this technology, and apparently able to move in and out of the system easily, everyone participates without question. People following me on the streets, harassment from Springfield Police, Sacred Heart does some classic CIA abuse (doctors somehow manipulated into participation): pretending to inject me with GPS twice, making odd faces, other comments, and refuse to provide treatments, kick me out of hospital. They didn't want me in their care because of what was going on.

-Springfield Police knew about radio wave technology, psychotronics, and are participating in the operation. They talked about it, and quoted private conversations I had on Facebook with friends about it, made fun of me, drove by house making chirp noises with a siren, and then threatened me about it in January/February 2011.

-March 13<sup>th</sup>, 2011, they were looking for a reason to come around me, they try to get me, are hurting me in secret with the technology. Officer Grice and Bezates attack and assault me in front of family, arrest me and claim I assaulted them (slander/libel/assault/battery/excessive force/illegal spying/corruption). They were out of control, lied in police report, and falsified everything. Grandpa witnessed incident. Police involved in sabotaging me in jail to hide secrets, "GEI sound," trying to ruin my legal case/hurt me. I'm sure both officers were involved in my secret rape and torture; they're both very angry. The police department refuses to provide misconduct reports, or to investigate abuse of it's officers, and the DA is protecting both. They definitely participated in spying and sabotage in jail, as they've made comments to family about conversations we've had in private, and on the phones. They may have recordings of phone conversations, but they are also secretly using this technology to do most of the monitoring and tracking of the situation.

-Officer Scott of the Oregon State Police (Salem) needs a special mention. In 2011 I called the state police about being raped and set up my staff, deliberate injury. He comes out and seems to know who I am. He's there to deny he ever did anything wrong, would help if something was really going on. He says he prosecutes staff all the time, that he doesn't hide abuse at OSH. It's like he knew what I'd been saying about how the state rarely prosecutes staff, and only goes after patients. He goes over the technology, says he was in the military. He refuses to read paperwork I had, "oh it's just a theory, it couldn't

possibly exist". "you need to have a paradigm shift" "just forget you know anything about this stuff". He seemed to only be out to push his agenda, like he had it all pre-planned. Later in 2012 he comes out and says "I investigated this stuff, it doesn't exist, no ones going to prosecute or do anything about the abuse" – He had an angry hatred for me, like he knew about everything that I'd been doing. Like I was pushing the issue. I speak to him, "I wish you'd change your mind" "I could die" He replies, "So what? People die". He pretty much refuses to let me speak when we talk, he keeps interrupting me like he doesn't want to hear or understand. He complained in November about one call my family and me made about the abuse, so he had me put on phone restriction for no reason. I didn't do anything wrong, they're trying to control me and close all the doors, make it hard to get help. Everyone I've spoken with at dispatch seems to know what's occurring, I mean certain female staff speak like they know me, like it's cute I called. They know of my situation and what's happened, they don't want to acknowledge or admit it. "it doesn't exist" because they don't want you to know about it. Officer Scott is a dirty thug to let me get raped hundreds of times and to pretend he isn't involved. To have me restricted when I am calling just once to report deliberate serious crime, with witnesses of abuse, gang stalking and staff pretending not to be doing it. I explained it in more detail when I spoke with him. The state police have a polygraph procedure in place for dirty cops who refuse to investigate abuse and crime they committed, and I think Officer Scott should be one of the first tested. This is a classic case of corruption/secret abuse of people, similar to what I've seen happen in many cases with CIA involvement. No one wants to admit to what they've done because of the seriousness of their crimes, and everything is supposed to be part of a secret operation.

-I also contacted Sgt Withers of Oregon State Police about the Bonita Tucker case. I asked how so many facts were left out, told him about my case. He refused to return calls.

-I endure all day abuse, violation, mutilation, and assault throughout  
2008/2009/2010/2011/2012.

-Staff from Anchors 1 involved: Cori (Female), Corey (Male), Dave Hampton, Teresa, Brandi, Adam, Collin, Michael, Jennifer, Eric RN, Elizebeth, many others. Lots of old 48B staff here, most of them were around when this started. Quote from Dave Hampton during the 2008 incidents "damn it's such a well oiled machine". They were making fun of my failed attempts to get help.

They can do a lot with an energy weapon, simulate all abuse and hazards digitally with precise control, automate and mame. Staff and people involved also are unreal, take advantage of opportunity and show serious willingness to hurt or kill to hide abuse. It's deliberate wanton abuse, as they call it, they take every change to get me. I could die any time. My life is ruined. Every square inch of body targeted and injured, dehydrated or turned to hard tissue with precise laser like radiation, memory and mind wiped out. I experienced MKULTRA style brain wiping and repatterning over the summer; they called it shock therapy, conditioning me for abuse, trying to destroy my body and brain on purpose with trauma and orgasms. They said I was weak and didn't like my complaints of abuse, that I thought it was rape. I was perfect the way I was, I was good, they were not. I did nothing wrong.

I got a new attorney in September 2012 who refused to help (Rebecca Davis). In September, I believe I had a psychologist suggest the abuse was real, that it couldn't be confirmed to be psychosis – I had witnesses to abuse, but I still have not seen the evaluation. I was sent back to OSH in October 2012 for a 370 “aid and assist” eval, but I have no idea why. I think my attorney and the judge was against me, and they may have been participating in the scandal. I needed protection from OSH, and I figured the psychologist understood. My attorney had me held back from court September 26<sup>th</sup>, 2012, and didn't tell me I was going to OSH. I had prepared a complaint to the judge which I told her I was going to make, and she apparently didn't want me to make it. I get back to OSH and staff special request I go back to Lighthouse 2, where all my old abusers were. Within a week of being back, Brady walks by and says, “put your lips together,” and begins to whistle, just like all staff started doing last year (They know I'm sensitive to noise, and Jeff Birkholtz conditioned me to fear the whistling in 2008. They would make noise around me to later claim I was paranoid, and that it wasn't occurring. They hoped I'd tell outside doctors about the odd abuse, and they'd deny it and pretend I was psychotic. It was also a method of conditioning me to fear them. It meant they knew I was being targeted and abused, and that no one was going to help. Jeff Birkholtz also sung songs, like “somewhere over the rainbow” as he walked by me, indicating I was being sent into “oblivion” and that everyone was on his side.) Staff members on Lighthouse 2 also all bought whistles and began parading around the unit and outside my door using them for no reason, and I have many patient witnesses. I was on restriction to unit for no reason for a week, and they tried to stop phone calls I was making to get help. Later I was placed on a false quarantine for a medical condition I didn't have. They turned away attorneys and refused access to law library during these periods. I did have a skin condition called tinea versicolor, but it wasn't related to the quarantine, and they were refusing to treat it for a month and a half, resulting in suffering, and additional serious scarring and damage to skin. They also began the medication override procedure, ignoring recommendations from the psychologist in September, I believe they're only doing it so they can try to hurt me with medication again. So far I've yet to get help. In October, staff also sabotaged the telephone system, blocking 800 numbers, and pin entry so no one could call long distance for weeks. My Google Voice from [oregonstatehospital.net](http://oregonstatehospital.net) was specifically blocked, as was the 800 number to my calling card, which was different from others. I was later placed on unnecessary restriction from the phone, they're refusing to allow me to make calls without them watching and listening to every call, and are trying to suppress what I have to say and who I can say it to, including reporting abuse. I heard comments that the phones were restricted to try and prevent calls during the election, to contain what I had to say about what was occurring at the hospital. I was also assaulted by staff one night in November in my room, which ruined my glasses. November 5<sup>th</sup>, 2012 They went to the judge and lied about my condition, suppressed and hid important evidence, and refused to allow me or my attorney more time to build my case. The administrative law judge at the hearing erroneously determined I could be medicated, and failed to perform an investigation into the reported abuse, and failed to validate the hospitals falsified evidence or testimony. The state also seemed prepared for the complaints, and they specially brought in assistant attorney general just to feel me out and defend the state at the hearing (normally Dr. St Just does the hearings for the hospital. there's just no way they don't know about the

abuse). I am waiting to get my own doctor now to come in and recommend other treatment, and I have hired a new private attorney to handle my case. Many staff on the unit still harassing me, I have over 8 witnesses of it occurring, and they've done it in front of camera (I have some dates/times). Whistling at me when they walk by, making comments when they do "I don't really care," "bring on your attorney" and other comments. I am being remotely controlled with the technology, comments and emotional/cognitive impressions from staff and others all day, Dr. Dick, sharing their thought and trying to really irritate me. Contradictory thoughts and messages, sharing ideas about what others are really thinking, rape and forces strong on my body any time I lay down, they all go on like it's not happening. This all adds up to a series of acts related to deliberate impediment and attempts to cause undue restriction, and attempts to prevent me from getting assistance. I am being battered with medication, which I consider a toxic substance. I've had allergic reactions, they know I can't handle it, force it anyway. My muscles immediately jammed up, my skin turned yellow, I could hardly talk or sit still, I couldn't sleep all night. They only want to make me sick while they play these games, they will never admit they know I'm not mentally ill.

There are over 20 inmate witnesses of abuse at OSH and Lane County Jail, where they helped sabotage and set me up. Playing games and then denying they were doing it, whistling and harassment, kicking door, making noise, and other things while using remote view and participating in the torture going on in my cell. These 20 people are just the ones I have the names of, and do not include people from 2008 or before. These people were in OSH or jail during 2011/2012.

(general during the years and after 2006/2007/2008):

The hospital/OIT/state police/others put me on the blacklist due to my legal troubles with OSH, which led to wanton abuse, me being stuck here without help or protection, and everyone trying to basically do what they could to bury me with false claims and abuse. They were told never to help me.

They are kicking me off the computer.
