technology.ppt describes the dangerous technology and programs developed by American psychiatrists, Oregon State Hospital, the CIA, FBI, and military.

I also describe the US DoJ's involvement in serious crimes in usdojandoregon.ppt - and abuse events leading up to my torture with psychotronics (weapons that simulate the paranormal) and synthetic telepathy - cia.txt describes being tortured, and targeted in Lane County jail, OSU, and on the streets.

Why is this relevant to me? I was involved in major scandal at Oregon State Hospital, staffers are very violent uninhibited and assault people and hide abuse to stay afloat - Bonita Tucker, inappropriately

involve me in a sexual relationship.  
She lied about it and staff protected  
her - I got stuck at OSH and abused,  
set up to look mentally ill. Then  
she struggled in belt culture, developed  
romantic relationship with patient ~~David~~  
David Anderson and aided in two patient  
escapes. Still, state of Oregon  
obstructed justice and tried to hide  
what happened, due to lack of  
liability insurance. I was targeted by  
staff and abused on purpose. Even  
the state police and OIT was involved -  
meanwhile the US Department of Justice  
investigated OSH, instead of helping to  
end abuse, they helped staff cover it up,  
and to beef up security. The feds  
had microwave based resonance technology  
to see and hear through the walls  
hospital wide, they called it a "live wire"  
it is also a remote brain computer interface -  
can read and manipulate brain waves,  
uses pulsed-modulated microwave emitter -  
can link staff together, peer into mind  
without peoples permission, used for illegal  
spying. It works because the brain produces  
large amounts of readable RF energy, and tools  
like EEG and radio antennas can read it.



I tried to expose it, and they decided to try to kill me to protect what happened. ~~It~~ Everyone in Oregon was involved Disability Rights Oregon, Governor Kulongoski, and ~~then~~ now Governors Kitzhaber, George W Bush and now Obama - they believe I should die to protect and hide the crimes they committed to protect this "national security" illusion they've created. They believe the technology is more important than me. The first words I ever ~~was~~ heard were, "Like you spy for the Statesman Journal, DeAnn Major spies for the CIA" - "you're being set up to look psychotic" - the simulated psychotics and secretly tortured me with this microwave based resonance machine. The Washington Post reports that this has happened before - in their 2007 article titled "Mind Games" - Army invented voice 2 skull in the 90's - for ~~now~~ over 5 years now I've been targeted and tortured, I've become aware that the feds will never respond to request for help, I am near death, FBI Agent Roberts is involved, Agent Rutledge, US DoD David Deutch, Robert Koch, probably Amanda Maxwell, US attorney in Oregon. I am seeking a criminal investigation into the misconduct and



illegal use of advanced EMF

US citizens and people thousands miles have

bill to come out, Denise Kucinich's

for vote in 2001, 2003, or 2005 -  
when it was introduced. I also didn't  
want ground based use - Russia has a ban.  
The US Constitution probably outlaws it, but  
no one is enforcing the rules properly.

Please help free my undirected  
energy weapon abuse, and write strict  
new laws to make technology development,  
US secrets and programs more transparent  
and open to the public. I believe that we  
should take away their right to classify  
details about how money is spent, technology,  
and programs to used here in the US,
