<http://www.obamasweapon.com/> More reading for the jist of my story maybe laid out a little differently than what's on my website: My case is both about the public being illegally spied upon and targeted with military weapons technology, and about myself being a target, victimized, and injured - My psychologist calls it whistleblower retaliation, but they basically have tortured and tried to kill me, and severely injured me. I am hooked up with whistleblowers from the CIA, DOD, US DOJ, and US Investigative Services who back me up, and I am the victim of these abuses. The guy I know from the CIA/DOD/US DOJ is Dr. Robert Duncan, PhD from MIT, Harvard, Dartmouth, and designed weapons/surveillance systems using satellites and radar for the government. Basically they spy on everyone, have the ability to remotely image the brain, decode thoughts, extract information from your brain including full memory, what you see, hear, think, feel, dream, passcodes, history, and more. They call it TAMI or Thought Amplifier and Mind Interface, or Remote Neural Monitoring. I was a target during a major US DOJ investigation here in Oregon- when I caught on camera w/ microphones Oregon State employees discussing the technology they were using on me, they tried to murder me using the directed energy capabilities of the weapons system. Basically, they flooded my body with radiation, beaming in sound and noise directly into my brain. This technique is built into the NSAs/DOD's radar systems, and they can basically beam in "radio frequencies" directly to your brain that heterodyne and alter the signals of your brain, allowing remote control and other abuses to occur. There are thousands of targets nationwide and the public is at risk all over. Passive monitoring and surveillance goes on, and the police all over know about it, as does state and local government. They do attack people and mess with them in secret, and they've had a long history of deliberate abuses of the public, mind control experiments, etc, dating back to the DOD/CIA program MKULTRA which resulted in over 100,000 victims. Today Dr. Robert Duncan believes there to be at least 10,000 victims concurrently being attacked or controlled with the weapons system alone. More details can be deciphered about my case below, where I include email and whistleblower and audio and video evidence. Some aspects of the case still need investigated. The state of Oregon refuses to turn over video and audio evidence where their employees were caught assaulting me, discussing the technology they had outside of the building to do all this (this was from August 2008 era). I live with daily electronic assault and physical abuse and am now suffering severe brain injury and neuro-muscular injury. I live having my body massaged with EMF/radiation, and they did all this to frame me to take the fall to cover up their crimes with this technology. Which is just one type of directed energy weapons problem facing Americans and the world. Read my stuff below for more details and insight and you will find more expert information and hidden history into this problem by visiting my website as mentioned: The technology today is so advanced that each country has the technology in their arsenal, especially the super powers. The United States has the largest amount of EMP weapons (we refer to them as directed energy weapons, linked to the SDI/Strategic Defense Initiative/Star Wars program). The first poster in a thread about this on [Slashdot.org](http://Slashdot.org) called out this article and Fox News as fear mongering, but if any country decided to attack us with one of these weapons, they'd be able to do some damage just like is asserted. An



issue is also not the politics because experts have been going over the mystery of directed energy for decades. In the United States, the whole directed energy issue is "classified" and more secretive than the Manhattan project (which was the project that developed the first nuclear bomb, which was pretty secretive). What is really going on, is they refuse to acknowledge their knowledge of the problem, and don't want to give public comment about it, and normally refuse to act in the public on the issue. What many Americans don't know is the government knows all about directed energy but they don't want the public to know about it because of all the experiments and crime that have occurred with it. There's like a big case of many with knowledge of directed energy getting assassinated, and the issue of the public being targeted with weapons attacks and torture with it. Senator Paul Wellstone was assassinated in 2003 with it (according to Jim Fetzer), the World Trade Center was dustified with it in 2001 (according to Dr. Judy Wood), thousands of people report being mind controlled and experimented on with it (or otherwise being murdered/hurt with it). The Strategic Defense Initiative is already out there and the EMP weapons are deployed globally. In all satellites, phased array antenna, and radar systems. There are literal "goldeneye" weapons capable of targeting both humans and machine alike all over the world. But let me give you a hint about SDI and Star Wars: It can both injure people, and protect them. In fact they can create a shield of electromagnetic energy around any town or city, or even an entire country to fully protect the area from EMP and nuclear blasts (in fact, I suspect the United States to be shielding itself to protect itself from psychic warfare and remote eavesdropping from other countries using this technology, to for one thing, prevent other countries from getting access to at least our top officials and generals brainwaves and thoughts in secret). Staffers and state covered this up and I was abused and had release sabotaged, and later in February 2007 Bonita was caught doing everything I said plus multiple staffers paid money to help aid in escapes and drug smuggling plots. The state did not arrest any staff involved, covered all this up... Statesmen Journal newspaper did not catch wind until December 2007 and ran the article exposing all this. Staffers also had covert military communication technology that allowed them to communicate via radar which beams a complex waveform into their brain, apparently it also allows my thought and memories and nerve impulses to be monitored remotely. Staffers on the recorded 48B hallway with cameras and microphones discussed the technology they had outside of the building to do all this, saying it could focus on just me. Staffers discussed that "they" thought the state lacked liability*

insurance, and used this technology to "violate his rights, just to say he does/doesn't have ADHD.". They said my case had been hidden from a judge in the Bonita Tucker case due to the lack of liability insurance. They said "the judge already made his decision" and stole legal notes from me with details about Bonita Tucker where I wrote out all the details, and hid and destroyed them to cover it up. Assaults and abuses started to happen, staffers came into my room and beat me bloody, and state covered it up claiming I attacked myself. A deliberate cover up ensued. I tried to hire an attorney and go to the media. August of 2008, the out of building surveillance technology was used to try to murder me in my room, flooding my body with radiation and directed-energy, beaming the sound into my skull and brain "like you spy for the Statesman's Journal, DeAnn Major spies for the CIA".. "You are being set up to look psychotic". There are patented weapons by the US Air Force and various military contractors for this technology. Including RF hearing effect for communicating speech, and a mind reading and altering radar patent from 1974, inventor Robert Malech. Lots of illegal surveillance, torture, murder attempts, abuses, set ups. Daily abuses. US attorneys involved include Amanda Marshall, David Deutsche, Robert Koch, Andrea Brown, and more. An FBI agent Roberts. This could really be CIA, and people they're working with to protect behind the scenes.. I do believe that the NSA and DOD run the radar and satellite systems. There are also numerous state, county, and city officials and police and civilians involved. I am today hooked up with two whistleblowers. Whistleblower #1: "AMANDA" from US Investigative Services (US intelligence contractor, did background checks on Edward Snowden and Aaron Alexis for NSA) confirming the weapons existence that she saw while she worked there and her belief I was targeted for psych/weapons experimentation. She says weapons used for unwitting communication which you cannot prevent during passive monitoring, as they steal your thoughts and remotely observe you. Whistleblower #2: Dr. Robert Duncan who worked for the CIA, DOD, and US DOJ. He went right from Harvard, MIT, and Dartmouth and into the CIA, where he helped the government make surveillance and weapons systems. He worked on satellites to read our heart rate, breathe, and track license plates from space/satellites. He helped the US Navy design some automated tracking of some crap as well, and has been to secret US Navy bases. This is the backbone for an electronic warfare system. He has disclosed more details about mind reading and altering radar, a system called TAMI or Thought Amplifier and Mind Interface based on Malech's patent which was deployed in all radar and satellites in 1976. United States continuing to target and lie about targeting Americans with electronic warfare and surveillance technologies that work beyond the telephone and internet tapping programs. This is about them ignoring the 4th amendment, and 14th amendments. This is about the 8th amendment being violated where I was locked up and tortured for years fighting them when I was arrested between 2011 and 2013 after the police beat me up over this. And against between Sep 21 2013 and March 5th 2014. Yes I was just criminally charged with an assault 4, where my rights were violated and I was tortured in jail, and they tried to sabotage my defense, left me without counsel, and did other abuses. The case was dismissed on March 5th 2014, because the DA who was involved in all this, named William Warnisher, decided after I submitted video and email evidence of this, that he could no longer prove he didn't do these things. Must do all this surveillance to control and abuse us, just like many of the whistleblowers, and Dr. Robert Duncan, and Russell Tice have said. I have experience with this. I have emailed FBI offices across the country for help. I went to the Inspector Generals. Even though it's all real, I am turned down for help, and the abuse ensues or intensifies. Most of these abuses date back over 60+ years to MKULTRA, COINTELPRO, and MINARET, programs which I don't believe anyone was ever disciplined for, never prosecuted .. showing you that our government doesn't take abuses of the public seriously. I don't want to die or go another day like this. I want to meet up with you guys, I hope for an injunction and media attention, .. The abuse will not stop unless someone helps me, as they will not stop on their own. I have radiation blasted into my brain daily, I have radiation massaging my genitals, they blast me with sound, images, dream simulations... I am at the breaking point, losing memory, and might not survive. I might be able to recover with a few months of serious neuro-rehab, physical therapy, but only once the abuse is stopped. They keep injuring me, refusing to let me heal. I have bleeding in my nose, super tightness in my body, inflammation, brain squeezing, and other injury really fucking me up, and they make it worse by using this radiation on me. I am worried about others being targeted, and I know they are getting targeted. It does allow passive observation, extraction of memories, and things even if you don't know they're watching you.
