requesting photographs of my assault by staff

on multiple occasions, I was assaulted by staff during my stay at the Oregon State Hospital.

for example, a staff member named Jeff Hodson brutally assaulted me, beating me with his fists over 10x times in 2008, along with 3 other nurses. the beating left my face swollen, bloody, and heavily disfigured. he also sophocated me on camera. OIT and the administration then helped cover this assault up. pictures and security footage with audio would have had to have been saved. I would like to request access to this evidence so that I can pursue a criminal complaint against mr. Hodson and OSH.

I also want copies of other photographic evidence, video and audio recordings, and public record relevant to the scandal I was involved in. I was assaulted by multiple staff and multiple involved patients who were helping the staff or patients involved in the scandal, Including the Bonita Tucker, David Anderson, Chris Walker, Adam Collier, and Martin Turner (staff), a lot of this the state covered up due to lack of liability insurance. My abuse was hidden and covered up to protect the state and protect the gruesome union at OSH.

Yes I had pictures taken by security at least 3 occasions due to assaults by staff or patients in 2006-2009, possibly 4 or more different times.

please get back to me. I was told that while OIT has copies of a lot of this, I need to make the request directly to OSH. I can make more specific requests if needed, and I can find out what is available.

it's funny to see how a dangerous man like Jeff Hodson could repeatedly assault a person, and this was not my first encounter with him, and years later, even with so much evidence, still go on to become the union vise president like nothing happened. he also assaulted me in 2004, shoving me against a wall without cause, lying about the incident, and helping to frame me to look mentally ill. also, I saw his record at OIT; he literally has 12+ abuse cases for assaults and other misconduct, more than I've seen most other staff with. I overheard him giving an employee advise in 2011, to a staffer on LH2, after he had assaulted and busted patient Thomas Smith's face up; Jeff Hodson literally told him not to admit to anything, that he was the pro at getting people off. That staff member then went on to claim it was an "accident" even though he was deliberately abusing Tommy Smith. I saw how badly Tommy's face was gashed open, I witnessed the whole incident. I know Jeff Hodson helped this staff member avoid criminal liability and helped instruct him on how to avoid incident with OIT. Jeff Hodson even to me in 2008, "don't mess with the best" very excited when OIT let him off. Yeah, Jeff Hodson is a pro, at manipulating the system and getting away with assault and battery. Guess that's how he made it to the top of the OSH union, eh? Now I see him complaining and hypocritically fighting about patient on staff assaults, you know.. with the attitude I see you nimrods with, I kind of suspect you cause 90% of these incidents to occur. I haven't seen anything like the amount of force your staff use used anywhere else; in private facilities, or group homes, where patients can be just fine and not get into any physical altercations, EVER. It only happens at OSH, with your violent nimrod staff who aren't event mental health or health care professionals. It's like they're a group of non mental health providers in control of the hospital purely for the state employee benefits, which is the case; no certification or background in mental health or medical care is required to get A+ benefits and control a large part of Oregon's economy.
