**SUMMARY:**

Sandra Harmon comes to the Portland International Airport in violation of an exclusion notice she was issued on September 25<sup>th</sup>, 2012. The exclusion is valid until 12/25/2012. She was arrested for an outstanding warrant for criminal trespass II and interfering with a peace officer, re-excluded and charged with criminal trespass II.

**ACTION TAKEN:**

On 12/21/2012, I saw a female in the front lobby of the police department. I asked her if she needed assistance. She was rambling about Officer Tracy Burt arresting her and making an error on his paperwork. I asked the female what her name was and she verbally identified herself as Sandra Harmon. Ms. Harmon told me that she had a speech disorder (I could clearly understand everything she was saying, although it didn't always make sense) and a disorganization disorder. She said she came to the airport because she was told she had a bench warrant and claimed it was Officer Burt's fault.

Officer Flinn covered me while I listened to Ms. Harmon ramble. I had Officer Flinn run Ms. Harmon in LEDS/NCIC through the communications center. Ms. Harmon came back clear. Officer Flinn learned that Ms. Harmon had been excluded from the airport, and that the exclusion was valid until 12/25/2012. Ms. Harmon was insisting that she did have a warrant. Officer Flinn had the communications center call Multnomah County warrants and ask them to do a hand search. A warrant for Ms. Harmon was located by hand search. The warrant was confirmed. The warrant was for failing to appear on the charges of criminal trespass II and interfering with a peace officer.

I arrested Ms. Harmon and escorted her into the police office. I advised her of her Miranda rights which she acknowledged that she understood by saying, "yes." Officer Flinn brought Ms. Harmon's rolling backpack and a large purse into the office. I was the one who put the handcuffs on, checked them for proper fit and double locked them. Then I placed Ms. Harmon in a holding cell while I completed a custody report. Officer Flinn issued Ms. Harmon a new exclusion notice. Officer Flinn placed Ms. Harmon's belongings into the property cage for safe keeping after we inventoried them per department policy. I took Ms. Harmon's money, a small purse containing her identification and credit cards, and her cell phone with her to jail. Included with Ms. Harmon's belongings was a copy of her property receipt with instructions on how to get her things back, a copy of her exclusion notice and a copy of the map that showed which areas she was excluded from.

As we exited the holding cell in an attempt to get to my patrol car, Ms. Harmon dropped to her knees and began sobbing because she wanted to take a red sweater with her, which she said was in her rolling backpack. Ms. Harmon cried that it was cold in jail and she wanted her red sweater. I pointed out to her that she had a jacket and a vest going with her. Ms. Harmon would not stand up and just sobbed while saying things that I could not understand. Officer Sahota assisted me in getting Ms. Harmon to her feet and to a patrol car.

While enroute to jail, Ms. Harmon told me that the reason she came to the airport was because she was told that she had a bench warrant and figured it's what she was supposed to do to get the warrant taken care of. When I suggested that she use her phone to call before coming to the airport after being excluded from here, she said that she only is able to text message from her phone and could not use it to make phone calls. She said she thought she was doing the right thing. I told her that she would still be able to get her things out of the property room, but that arrangements would have to be made before she came to the airport.

Once at MCDC, Ms. Harmon signed a probable cause waiver due to the Thanksgiving holiday. I left Ms.
